Fire Arts 6th Annual Juried Show: Our Endangered Planet

Mark your calendar for Fire Arts 6th Annual Juried Show! Artists 18 years and older are invited to submit 3-D work for this special themed show, "Our Endangered Planet." This will be a juried show comprised of work created by artists who have a great concern for our planet and the fate of its creatures and plant life, large and small.

This show will take place at Fire Arts Inc. during May 3rd through June 28th of 2019. Acceptable media for this show is Clay, Stone, Metal, Glass, Wood, Fiber Arts, etc.

Up to two pieces may be entered. Selected work will be on display in our showroom during the months of May and June, with an opening reception taking place on the First Friday in May. First Place (Best of Show), Second Place, and Third Place awards will all be presented at that time. A People's Choice award will be given during the following First Friday event in June.

Guidelines and Rules

Entries Due: *All Submission Information must be sent in from March 16 – April 13, 2019*

Submission must include:

Digital Images

Application

Entry Fee

*Waiver of liability signed

**Bring the waiver of liability when delivering the accepted work to Fire Arts Inc.*

3-D Media

Clay, stone, wood, metal, glass, fiber arts, mixed media, etc.

Rules

Artists must be 18 years of age or older.

Insurance for art work is the sole responsibility of the artist.

Artists may submit up to two separate pieces. (Art work designed with multiple pieces as an installation counts as one submission.)

Since Fire Arts' modest exhibition space is 850 sq. ft. with a 10'

ceiling and limited wall space, maximum size restriction preferences are 3' horizontally, 6' in height, and no more than 100 lbs. in weight.

All work should be self-supporting, or be able to be placed on a pedestal. All reliefs and other hanging work must be equipped with appropriate hardware for hanging.

It is **suggested** that each piece have up to three digital images submitted from different views. **Suggested** image resolution is 300 dpi. with print dimensions 5 x 7 inches or larger.

Submit the application form along with the images of each piece entered.

When sending digital images of each piece, label the images (example: Entry A / view 1, Entry A / view 2, Entry A / view 3, etc.).

Or send entry fee and hard copies of paperwork to Fire Arts at: 305 East Colfax, South Bend, IN 46617 — and digital photos to **info@fireartsinc.com** along with your name, contact information and the name of the show "Fire Arts 6th Annual Juried Show."

Our distinguished juror for this show will be sculptor and 2-D artist Mike Slaski. Since this is a juried show submitted pieces are not guaranteed a place in the show. Jury selection will take place through digital images sent in. ***Participating artists will be notified by April 20 via email of the piece(s) that won a place in the show.***

Deliver accepted pieces by April 27, 2019 to: Fire Arts Inc.

Art work accepted into the show will need to be delivered to Fire Arts along with the signed waiver of liability during open hours from April 20 - April 27. Attach a copy of the appropriate labels (Entry A or B) to the back of each piece.

Art work can be available for sale.

Fire Arts will take a 30% commission on any sales of exhibiting work in the show. Purchasers may take possession of their purchased artwork after June 28.

After the show closes on June 28, artists are expected to pick up their work from June 29th through July 27th during open hours, or make special arrangements for pick up.

After July 27th abandoned work will become the property of Fire Arts Inc.
